**STIPULATION AND [PROPOSED] SCHEDULING ORDER
GOVERNING POST-TRIAL BRIEFING**

IT IS HEREBY STIPULATED AND AGREED by the Parties hereto, through their undersigned counsel and subject to the approval of the Court, that post-trial proceedings shall be governed by the following schedule:

Anthem's Opening Post-Trial Brief	April 12, 2019
Cigna's Combined Opening and Answering Post-Trial Brief	May 17, 2019
Anthem's Combined Answering and Reply Post-Trial Brief	June 21, 2019
Cigna's Reply Post-Trial Brief	July 26, 2019

The parties agree that (i) Anthem's Opening Post-Trial Brief shall be limited to 20,500 words, (ii) Cigna's Combined Opening and Answering Post-Trial Brief shall be limited to 22,500 words, (iii) Anthem's Combined Answering and Reply Post-Trial Brief shall be limited to 14,000 words and (iv) Cigna's Reply Post-Trial Brief shall be limited to 12,000 words.
